1. Call to Order/Approval of Agenda

3. ARCH Report - Michelle Griffith

Michelle Griffith gave a brief update on the following items:

- Home selling in Bellevue located at 8th and Oak is closing very soon
- Home moving from Warm Springs to Alturas Drive is happening very soon
- Another home donated to ARCH on Alpine Way in Ketchum will also be moving soon, location TBD
- Quail Creek passed through P&Z in one meeting and George Kirk's still has to go to his P&Z meeting on April 29th meeting before the County Board of Commissioners, Clear Creek, LLC PUD Amendment approval
- ARCH received a grant award from Wells Fargo Bank for moving houses
- ARCH plans to apply for more funding to rehab homes and will confer with BCHA as to what size of home and desired locations for the homes are needed

4. Comments from Liaisons from Elected Bodies

Jim Slanetz, City of Ketchum Council member and liaison to Blaine County Housing Authority, said the City is still working through the URA on the land swap, and that there was some legal "wrangling" with regards to title still happening.

Michelle Griffith, City of Sun Valley Council member and liaison to Blaine County Housing Authority noted that the Sun Valley City Council discussed and approved Bonnie Moore to continue to represent the City of Sun Valley on the BCHA Board despite having moved outside of Sun Valley. Michelle Griffith reminded BCHA board members that David Patrie is working with the City of Sun Valley Staff to compile information with respect to housing for reporting to City of Sun Valley Council as contracted this fiscal year.
