Nathan Harvill, BCHA Executive Director reported that the Picabo lot would need to be developed in accordance with the Blaine County Zoning & Subdivision code, it would be an ownership unit within income categories 3+ - 5, 70% - 120% of AMI, 90 to 100% of AMI, if possible. Over the course of time, BCHA will get more input from Picabo residents.
